1. Who we are

Paragonday is a timekeeping and coordination product provided by Teal Process & Company LLC. These Terms explain the rules for using Paragonday, including the website, web app, iOS app, widgets, iMessage features, and related services.

2. Using Paragonday

You may use Paragonday only if you can follow these Terms. You are responsible for how you use the service and for any information you choose to add, connect, or share.

3. Age requirement

You must be at least 13 years old to use Paragonday. If you are under the age of majority where you live, you should use Paragonday only with permission from a parent or guardian.

4. Accounts and connected services

Some features may require you to sign in or connect another service, such as Google Calendar. If you connect a third-party service, you give Paragonday permission to access that service only as needed to provide the features you request. You can disconnect third-party services through your account or provider settings.

5. Calendar and location features

Google Calendar events are accessed and temporarily processed to display or manage them in the interface. Paragonday does not currently store Google Calendar events on its own servers.

Paragonday uses location to calculate sunrise, sunset, and sun-relative time. Depending on the surface, this may include your device's current location, a location you search for, or a location you save. Paragonday uses location only to provide timekeeping and coordination features.

Paragonday does not sell location data or use it for advertising. Paragonday does not use location data to track where you go over time.

Some location calculations may be handled on your device, and some may require sending coordinates or a selected place to Paragonday servers or service providers so the feature can work.

6. Your content

You keep ownership of the content and information you provide. You give Paragonday permission to use that information only to operate, improve, protect, and provide the service.

7. Acceptable use

- Do not use Paragonday to break the law or violate someone else's rights.
- Do not interfere with, reverse engineer, overload, or abuse the service.
- Do not try to access accounts, systems, or data that you are not allowed to access.
- Do not submit harmful code, spam, or misleading content.

8. Payments

Paragonday does not currently offer paid plans or process payments. If paid plans are added later, pricing, cancellation, and refund terms will be shown before purchase.

9. Intellectual property

Teal Process & Company LLC owns Paragonday, including its name, design, software, text, graphics, and other product materials, except for content owned by users or third parties. These Terms do not give you ownership of Paragonday's intellectual property.

10. Beta and experimental features

Some features may be experimental, unfinished, or change over time. We may add, change, pause, or remove features at any time.

11. No warranty

Paragonday is provided "as is" and "as available." We do not promise that the service will be uninterrupted, error-free, or perfectly accurate. Time, location, sunrise, sunset, calendar, and coordination features should not be used where mistakes could cause harm.

12. Limitation of liability

To the fullest extent allowed by law, Teal Process & Company LLC will not be liable for indirect, incidental, special, consequential, or punitive damages, or for lost profits, data, goodwill, or business opportunities. Our total liability for any claim related to Paragonday will be limited to the greater of \$100 or the amount you paid to use Paragonday in the 12 months before the claim.

13. Termination

You may stop using Paragonday at any time. We may suspend or end access if we believe you violated these Terms, created risk for the service, or used the service unlawfully.

14. Privacy

Our Privacy Policy explains how we handle information. By using Paragonday, you also agree to the Privacy Policy.

15. Governing law and venue

These Terms are governed by the laws of New York, United States, without regard to conflict-of-law rules. Disputes will be handled in courts located in New York, unless applicable law requires otherwise.

16. Changes

We may update these Terms from time to time. If changes are material, we will take reasonable steps to notify users. The updated Terms will apply after they are posted or otherwise made available.
